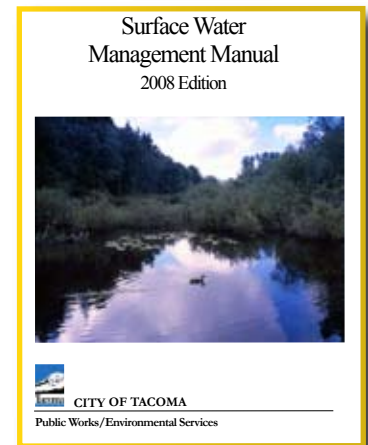
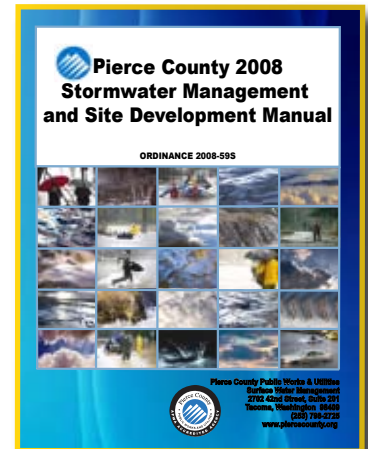
Pierce County joins neighboring counties Snohomish, King and Thurston in approving corrugated HDPE through 60-inch diameter. The Pierce County 2008 Stormwater Management and Site Development Manual is currently online at www.piercecountywa.org and has an effective date of March 1, 2009. Volume III, Section 4.7.3 Pipe Materials states that all storm drainage pipe shall be a rubber-gasketed concrete pipe or corrugated high-density polyethylene (AASHTO M294, Type S) with watertight joints.

Additionally, the City of Tacoma has added corrugated HDPE to the Pipe Materials section in the 2008 Surface Water Management Manual. Watertight, corrugated HDPE (Type S) 4 through 60-inch has been added to Volume III, 3.4.1.5 Pipe Materials section. This new SWM Manual is effective starting September 22, 2008 and is available online at www.cityoftacoma.org.
